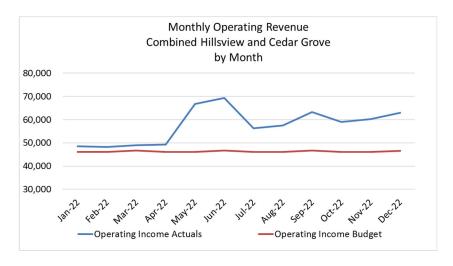
EXECUTVE SUMMARY

Year-to-date operating income is 23.6% over budget and operating expenses are 24.7% over budget.

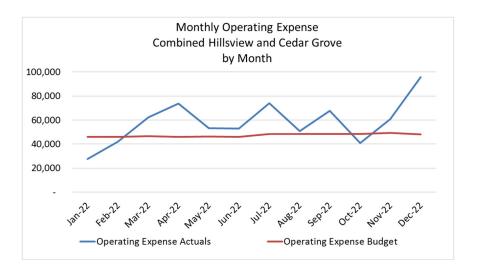

OPERATING REVENUE AND EXPENSE

Year-to-date operating revenues totaling \$685,906 exceeded budget expectations by \$131,002 or 23.6%. The primary reason for this variance is due to better than expected prorate for the operating fund subsidy. The budget assumed a 92% prorate, whereas the actual interim prorate through October was 104.93%. An increase in tenant revenue also contributed to this variance.



Year-to-date operating expenses in the amount of \$689,535 were over budget by 24.7%. The primary reasons for the variance were unexpected water mitigation expenses, greater than anticipated floor covering expenses, and higher than budgeted elevator maintenance costs at Hillsview. Cedar Grove also saw a rise in expenses due to flooring and cabinet repair costs to fix mold damage. The chart below illustrates the various spikes attributable to these expenses.

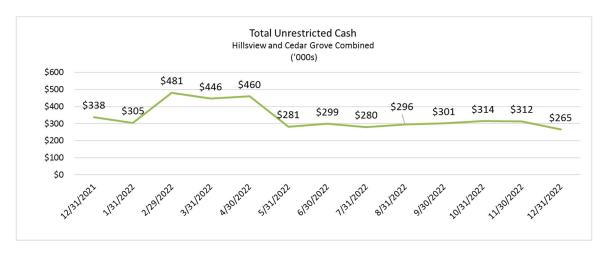


CAPITAL ACTIVITY

Capital project expenditures were under budget by 56.3% due to lower than projected expenses related to unit upgrades. Three unit upgrades were budgeted during 2022. However, no unit upgrades were completed as actual timing is dependent on unit availability. This variance was partially offset by capital construction costs related to the Cedar Grove envelope and roof project that was budgeted to be completed during 2021 but was delayed due to the weather conditions and the availability of materials.

CHANGE IN UNRESTRICTED CASH

Since the beginning of the year, unrestricted cash decreased by \$73,038 primarily due to the repayment of the contract retention and reduction of accounts payable. These amounts were partially offset by the receipt of capital grant receivables that were outstanding at year-end.
